Garage Variance – 8740 Rollin' Sunset Dr.: Carissa Blagborne made a motion to grant the 1-foot variance; seconded by Brian Koetz. Motion passed unanimously.

Close alleyways and W. 9th Street: Discussion was held on which areas to request was done by Council and Lance Ladewig. Requested alleyways in Block 64 and Block 65 and South D Street between those 2 blocks, plus South E Street between block 64 and block 84. Mark Potter made a motion to hold a

public hearing on Tuesday, September 10, 2024, at 6:00 pm. Motion seconded by Lisa Gibbs; motion passed.

Internal Control Memo: The memo was requested by our auditors to show what the Clerk-Treasurer and Assistant Clerk do regarding the money coming in, getting deposited; payroll procedures, cash receipts; water/sewer billing; general ledger posting & journal entries; bank reconciliation; debt and investment transactions. Carissa Blagborne made a motion to accept the internal control memo seconded by Lisa Gibbs. Motion passed unanimously.

Stockton Fest banners: Xavier Riser is requesting to place a banner on either side of town, one down on the west end on the City property. It will be for September 13th & 14th. Mark Potter made a motion to allow the banners; seconded by Carissa Blagborne. Motion passed.

BUILDING PERMITS

New addition & garage: Sara Morey was in attendance to request a building permit for a new addition to the back of the house and a new garage. Greg Olson has looked at the plans and approved. Dave Johannes made a motion to approve the building permit. Seconded by Carissa Blagborne; motion passed.

CITY MAINTENANCE

- Water hydrants will be flushed next week.
- The generator at the well is up and running but Lift Station #1 is done manually until they can fix it with a delay switch.
- Ditch along E Street, between 5th and 6th Street is eroding; Mark Potter will look at it to determine what will be the best course of action.
- Mayor Johannes asked to have a closed employee meeting at the September 10, 2024, council meeting.

Lisa Gibbs made a motion to close the Stockton City Council meeting, with a second from Carissa Blagborne. The motion passed unanimously; the meeting adjourned at 6:58 PM.
